The OHS is controlled centrally in its strategic aspects by ASC Technologies AG, Hösbach, while local implementation lies within the responsibility of the Subsidiaries in the respective countries.

Mission

Our mission is to minimize risks, prevent accidents and sustainably protect the physical and mental health of all employees through effective occupational health and safety measures. In doing so, we integrate occupational health and safety into all business process planning and decision-making structures:

Principles

ASC Top Management is committed to the following principles:

Legal Compliance: All relevant occupational health and safety laws, regulations and standards are complied with in every country in which we operate.

Prevention before reaction: We act with foresight in order to identify, assess and avoid risks at an early stage.

Safe work as everyone's responsibility: Occupational health and safety is the task and responsibility of every employee – from management to individual team members.

Health and well-being: In addition to physical protection, our focus is also on mental health, ergonomics and work-life balance.

Integration into everyday work: Security aspects are integrated into all processes, projects and decisions – from office design, production work benches to software development.
